

## FUND DESCRIPTION

The SonicShares™ Airlines, Hotels, Cruise Lines ETF (TRYP) provides exposure to a global portfolio of companies within the airline, hotel and cruise line industries. TRYP is an indexed ETF that seeks to provide performance results that correspond before fees and expenses, to the Solactive Airlines, Hotels, Cruise Lines Index (the "Index"). The Index consists of mid-to-large- capitalization companies listed on exchanges in select countries that derive at least 50% of their revenue from specific activities within the airline, hotel and cruise line industries.

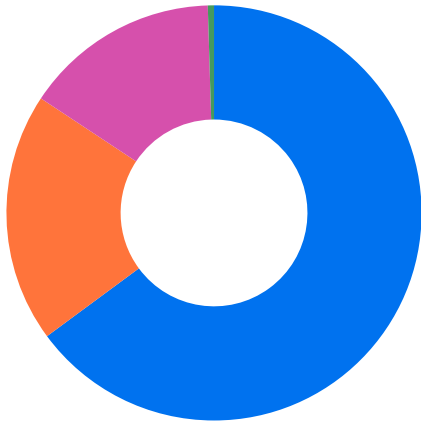

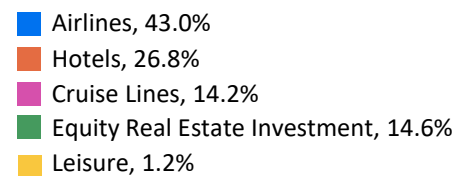
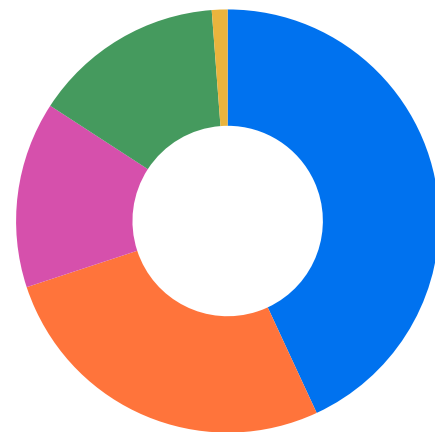
